KEY TO COMMUNITY FEATURES

- A - COVERED WALKING BRIDGE** - Trail provides easy access to & from nearby park & beach and downtown shops & restaurants.
- B - NORTH ENTRANCE** - along Lakeview Road.
- C - SALES CENTER & MODEL** - Start your tour here.
- D - CLUBHOUSE** - Owners enjoy this wonderful facility; indoor & outdoor pools, sauna, whirlpool, locker rooms, exercise room, & comfortable lounge with kitchen.
- E - TENNIS COURTS** - Two courts are located adjacent to the Clubhouse.
- F - PRAIRIE** - Sown with about two dozen native Wisconsin grasses & wildflowers.
- G - SANITARY SYSTEM** - A state-of-the-art FAST system serves all of Cottage Glen. The restored prairie doubles as the drainfield.
- H - WATERWORKS** - Well taps into what is believed to be a Lake Superior aquifer. Water is tested regularly to meet the requirements of the Wisconsin DNR.
- I - TRAILS** - Appreciate the natural beauty of the property while walking these paths.
- J - STORAGE & RECYCLING** - Workshop for the caretaker plus a place for trash and recycling. There is also space for boat and trailer storage.
- K - CARETAKER'S RESIDENCE** - Caretaker watches over CG from this charming home.
- L - BLUFF** - Nearly 5 acres of bluff lands are protected by a conservation easement.
- M - SOUTH ENTRANCE** - along Lakeview Road.
